Strengths

- **Global multidisciplinary scope:** covers public health, nutrition, maternal/child health, emerging diseases.
- **Full open access:** all articles are freely available.
- **Fast editorial processing:** 21 days to first decision, ~106 days to acceptance.
- **High visibility:** over 800,000 downloads/year; strong altmetric impact.
- **Alignment with SDGs:** >50% of 2024 articles linked to UN Sustainable Development Goals.

Weaknesses

- **Moderate impact factor:** lower than top-tier journals in nutrition/public health.
- **Single-blind peer review:** potential for reviewer bias.
- **High publication cost:** ~\$2,790 APC may be a barrier in resource-limited settings.
- **Thematic restrictions:** no longer accepts Mendelian randomization studies.
- **Editorial ambiguity:** historically based in Bangladesh, now UK-based via BMC.

☐ Best Suited For

- Research with global health relevance.
- Public health and nutrition topics, especially in LMIC contexts.
- Authors needing open access with relatively fast publication.

☐ Less Suitable For

- Researchers seeking top-tier citation metrics.
- Studies in genetic epidemiology (e.g. Mendelian randomization).
- Unfunded authors unable to cover APC fees.

☐ Final Verdict

Journal of Health, Population and Nutrition is a credible, open-access journal with solid indexing, broad scope, and efficient workflows. While not among the highest-impact venues, it is a strong platform for global health research, especially from underrepresented settings.
